THE MUSICAL INSTRUMENTS COLLECTION MUSEUM OF FINE ARTS, BOSTON, MASSACHUSETTS

The view shows a portion of the collection purchased for the Museum in 1916 by the father of Leslie Lindsey Mason, from the Reverend Francis Galpin. Details of individual instruments in the collection are to be found in Bessaraboff, *Ancient European Musical Instruments*, Harvard University Press, 1941. Although not large in numbers, this famous collection is unique in that an example of almost every known type of musical instrument is represented. The collection is further noteworthy in that it is a working collection in which many instruments are used in performance and all are fully accessible to qualified students and players. The large workroom and display area are air-conditioned and humidified in the interests of preservation and chairs and music stands bespeak active use of the facilities.

As with our first meeting at the Smithsonian, and the second Boston meeting, we can all fully expect to experience another stimulating conclave. With the appearance of the next NEWSLETTER this Fall, a call for papers will once again go out. We can all seek satisfaction in our mutual efforts and enthusiasm thus far, and join in anticipation for the coming year.

REPORT OF THE SECRETARY...

The second annual business meeting of the AMIS began at 9:30 A.M. on April 29, 1973 at the Boston Museum of Fine Arts. Dr. Robert M. Rosenbaum, President, presided.

After a brief welcome, Dr. Rosenbaum extended the appreciation of the Society to Cynthia Hoover and Barbara Lambert for their efforts in preparing the two day meeting. Members in attendance seconded Dr. Rosenbaum's accolade.

Linda Tauber read the Secretary's report of the first annual meeting held in 1972 at the Smithsonian Institution in Washington, D.C. The Secretary also read the results of the election held this year. As a result of a mail ballot the new officers are:

Dr. James M. Swain read the Treasurer's report and stated that as of April 29, 1973, the treasury held \$565.02, with membership at 230. Both reports were approved and seconded.

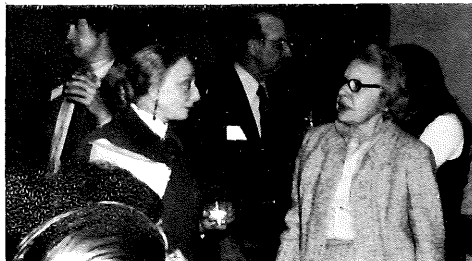
Dr. Rosenbaum announced to the membership in attendance that Dr. Swain had resigned as Editor of the Newsletter. All present showed their appreciation of the excellence of Dr. Swain's work in preparing the Newsletter. Mr. William Maynard will assume editorship beginning with the June issue. Dr. Swain will assume the post of chairman of the membership committee.

Dr. Robert Warner spoke next and invited the Society to hold the 3rd annual meeting at the University of Michigan where the Stearns Collection is on display. Dr. Warner gave a brief history of the collection and further discussed the locale of the school and other items of interest. It was decided by the members to hold the meeting at the University on April 5, 6, and 7th, 1974 and thanks were extended to Dr. Warner for this invitation.

The last order of business was the introduction of Dr. Thomas Forrest Kelly who was appointed by the Board of Governors to edit the forthcoming AMIS Journal. Although Dr. Kelly was not in attendance, Dr. Rosenbaum reviewed the Board meeting and pointed out the responsibilities of the new editor and indicated that all interested parties were in agreement. An editorial board will soon be formed. Also discussed was the possible costs of a journal, and ways of increasing income of the Society to finance such a venture. A tentative date of publication was put at 12 to 16 months.

The meeting was adjourned at 10:15 A.M.

EDITOR'S REPORT ON THE BOSTON MEETING ...

The cover photo of this Newsletter shows a partial view of the Leslie Lindsey Mason Collection (formerly the first Galpin Collection) housed at the Boston Museum of Fine Arts. It was with this collection in mind that over one-hundred members eagerly attended the opening session of the 2nd Annual Meeting of AMIS on Saturday, April 28th. Although the papers were read in an upstairs lecture hall in the museum, members were given liberal access to the collection by the Keeper of the Instruments, Ms. Barbara Lambert. It was a delight for the visitor to be able to see, touch, and even play upon some of the examples in the collection.

As can be seen from the scheduled sessions (summarized below), a wide range of subject matter was discussed. Following each paper, time was available for questions from the audience. A slight departure this year was the inclusion of two panel discussions.

Dr. Rosenbaum moderated a panel dealing with collecting practices and the philosophy of collecting and invited Edith Friedman (Detroit), Andre Larson (North Dakota), William Maynard (New York), Eric Selch (New York), and Dr. G. Norman Eddy (Mass.) to participate. Mrs. Hoover, chairing the Instrument Makers Forum, sat with panelists Charles B. Fisk (Organ), Frank Hubbard (Harpsichord), Friedrich von Huene (Recorders, Flutes), and Donald Warnock (Lutes, Viols, Guitars). As with the papers, questions were invited from the members in attendance.

Social activities were not overlooked at this productive meeting. Many members enjoyed the food, drink, and conversation which prevailed at the reception and dinner held at Boston University on Saturday evening. Professor and Mrs. G. Norman Eddy were sponsors for this affair which was a highlight of the conference.

At the business meeting on Sunday, Dr. Rosenbaum extended the Society's appreciation to Ms. Barbara Lambert, hostess for the 1973 annual meeting of the AMIS, and to Mrs. Cynthia Hoover who chaired the program committee. All in attendance seconded the President's words of esteem.

The 1974 meeting will be held at the University of Michigan where the Stearns Collection is housed. Dr. Robert A. Warner, Curator of the Stearns Collection of Musical Instruments, has extended the invitation to the AMIS for April 5, 6, and 7. More details will be forthcoming in future editions of the Newsletter.

FIRST AMIS PROJECT

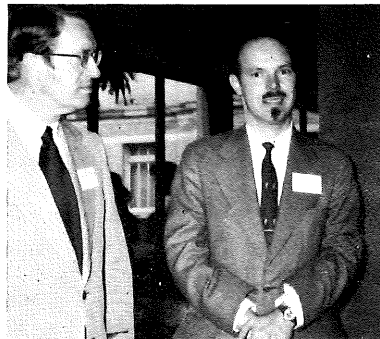
